KENT FAMILIES OF THE COLONIES 1600S

In researching my Kent ancestry I discovered two other Kent families in the early 1600 in Massachusetts. There is no known relationship between these families at this time.

My Ancestral Kent is John Kent who had two brothers named Joshua and Joseph Kent. According to a ships manifest, they arrived in the Colonies in 1645 on the ship Increase from Nyland, Suffolk, England. John lived in Dedham and Charleston, Ma. John died in Charleston, Ma. Joshua lived and died in Dedham, Norfolk, Ma. Joseph lived and died in Swansea, Bristol, Ma that became a town in Rhode Island. No English ancestry has been found at this time on these three brothers other than the ships Manifest of the Increase.

I am writing this document about the reports in this file that present the other two Kent families. The purpose of this documents is to simply provide information but not a complete genealogy report. I have written three other documents about the Richard Kent and his son John Kent. Some researchers prior to 1900 have authored books that contain errors about the correct relationship of Richard's son John Kent and my ancestor John Kent.

Richard Kent came to the colonies in 1634 from Wallop, Hampshire, England and lived and died in Newbury, Essex, Ma. He had two wives. First wife died in England. They had 3 children. Coming to the Colonies, Richard married again, and this couple had a son named John Kent born in 1645. Arriving with Richard Kent was related Kent families that lived in the same area as Richard. Documents seem to be plentiful to find information about this Richard Kent. There is documents of his ancestry in England.

Thomas Kent was born in Over Wallop, Hampshire, England in about 1594. He immigrated to the colonies around 1635 and died in 1658. He lived and died in Gloucester, Essex, Ma. There are some documents on this Thomas Kent; however, his documentation is less than most folks and nothing is presented about his English ancestry. I have found some documents that list This Thomas Kent related to the above Richard Kent but nothing confirming this relationship.

The fact that both of Richard and Thomas Kent came from the Wallop, Hampshire, England could lead one to believe they may be related. That would take more research.

PREFACE

A few words about the research are needed.

First, it is important that I try to support the data with documents or media that support the data of each individual. This helps to validate and provide confirmation of the genealogy history recorded about a person and their families. In some cases I have seen many forms of data, but I only attached those that provide proof to help support my recordings. If I attached all I could find would provide too much for my computer files and overload the presentation.

In United States history are numerous varieties of record types that have been preserved. Each of these records provide the trail of the people and their documented history. There are many sources that provide information of this documented history. In this book are footnotes of the source documents or places this research has been recorded. There are so many types of sources to mention here, but this book provides some of that information as recorded in my Family Tree Maker (FTM) file.

Some of the data has been found or learned but have no supporting documentation. Why? Because to maintain limited electronic files; and that some of the information has been discovered on many sources. In some cases, it is real information known by people of these families.

Ireland is divided by two territories. Northern Ireland, and The Republic of Ireland (the Irish Free State). Northern Ireland is under the control of British rule. The Republic of Ireland is its own sovereignty nation. The name "Éire" is the nickname or name used for Ireland.

First, one has to understand the land divisions of countries. This helps understanding to find people and where they lived.

One important note about individual and family names. Each surname coupled with given names you will find many of the same name or combination of names. Therefore, other items such as parents, birth, death, marriage, territory, and possible other items are required to ensure one has identified the current person and family.

Enjoy reading, but there is so much to learn. This document will provide a base for anyone wishing to do genealogy research or just adding to this family information.

RESEARCH NOTES

Doing genealogy research is a long term and time-consuming task. If one is doing it for real, they will collect a great amount of data about life of people, the territory they lived, and learn about the uniting of families. For this researcher, there is much learned that is way above what is taught about history in school classes. Research can include working with on-line resources in today's Internet and can include travel to obtain information and documentation from Federal, State, County, City, or towns from records they kept. Cemetery records are a great source found on-line via the Internet.

There are many avenues why folks do genealogy research. For this researcher, I am not writing a book, I am trying to learn of past family and a small bit about them. I am not recording every detail that is possible. If I did, I would not be able to share what I have discovered in this book and I would still be on the road to discovery.

What is in this book is free to all to read, print, or share as they desire. This information is public and can be found by others; therefore, I am not doing this for any monies or profit, just for the pleasure of doing this research and a great retirement hobby for me.

This research has been ongoing between 2000 to 2021 to compile and record in this book. There are many resources, these are just some of them.

The following is a sampling about what I used to do research.

2. "Family Search" [<https://www.familysearch.org/en/>] (Free to the public] web site that is open to anyone. This site is created and supported by The Church of Latter-Day Saints in Salt Lake City, Utah (aka Mormon Church or LDS).
3. Using an Internet browser to search by varies names or phrases does help locate some information.
4. Primary source documents such as: US Census, Birth, Death certificates, cemetery records, civil documents, and immigration records or other documents that support the validation of family names and their link to relatives.
5. Find-a-Grave: [<https://www.findagrave.com/>]. In the attached files you may see the term "**Memorial ID**" with a number sequence. By going to the Find a Grave web site and entering this Memorial ID, that will take you to the grave information that has been recorded by folks who go to cemeteries and document the graves. In some cases, you will see the grave maker and other information folks have recorded for that person. In some cases, there are links to parents, siblings, and children along with spouses that all have a Memorial ID recorded.
6. Historical Societies and Internet Genealogy resources

NOTES:

1) ANCESTOR: Also known as a forefather, fore-elder or a forebear.

2) DESCENDANT: Are descending after a forefather, fore-elder or a forebear.

- **Meaning of "direct descendant" as opposed to "indirect descendant"**

1. A direct descendant is someone who can trace their lineage by "child" relationships all the way back to the desired ancestor.

2. A non-direct descendant has to go through a "cousin" or "by marriage" or some other non-child relationship in order to find the desired ancestor.

Definition of genealogy.

1. An account of the descent of a person, family, or group from an ancestor or from older forms.
2. Regular descent of a person, family, or group of organisms from a progenitor or older form: pedigree. The study of family ancestral lines.

Introduction

The following pages list data for all known family members as of January 25, 2022.

Each immediate family is presented in their own section that contains a graphical family tree as well as a description with information about each referenced person and their children.

Any files/Media collected is attached to a person or family is pictured with each family.

The child section provides information about the children of the preceding couple. When a child has offspring of their own this is presented in a separate family section for that child. In this case a '+' is used to denote that an individual will appear later in the book as a parent with his/her own children and there is a link to the appropriate family reference number. Each spouse and their children is a "Nuclear Family".

For children with partners but no offspring the partner data is given with the reference family.

Roman numerals, followed by a period, are used to indicate the birth order.

In the chapter titled "Families of the Starting Person" the ancestors of Richard Kent are presented in a form of an enhanced Pedigree Chart which displays the graphic representation of their direct-line ancestors and the children of the couple. This chapter contains information about the couple whose ancestors are listed in the later chapters.

The chapter titled "<HeadlineFamilies>" provides details (as known as of this publication date) for the ancestors of Richard Kent.

There is a chapter for each generation.

Relatives are listed in the order of the nearness of their relationship.

Sources for the information provided are given in the footnotes.

This document reports the details of 38 individuals, of whom 21 are male and 16 are female. The sex of one individual is unknown. Of the 25 individuals with recorded birth and death dates, the average lifespan was 56.2 years. Of these, 15 males averaged 58 years, and 10 females averaged 53.5 years. The longest living male was Gilbert Kent (1538–1618), who died aged 80. The longest living female was Dorothy Emma Short (1590–1677), who died aged 87.

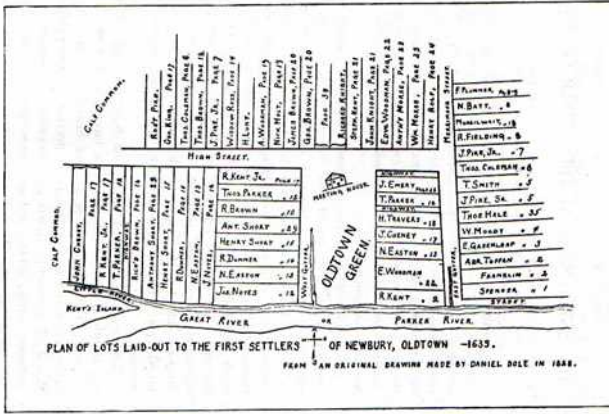


Figure 1: Newbury 1635 Plots

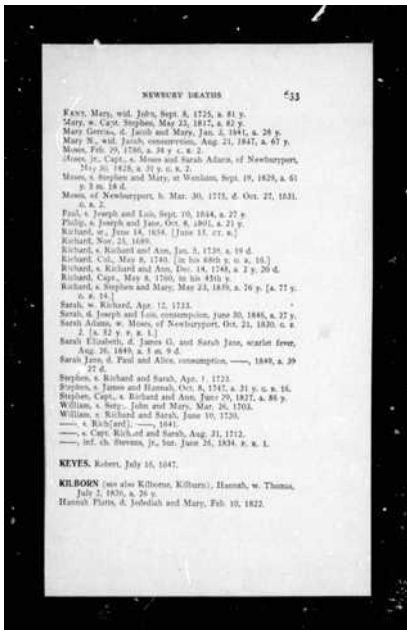


Figure 3: Massachusetts, Town and Vital Records, 1620-1988

RICHARD KENT SR.

ORIGIN: Unknown (but see *ASSOCIATIONS* below).
MIGRATION: 1634 on the *Mary & John* (on 26 March 1634, "Richard Kent" was enrolled at Southampton as a passenger for New England on the *Mary & John* [Drake's Founders 70]).
FIRST RESIDENCE: Ipswich.
REMOVES: Newbury 1635.

OFFICES: His inventory included "one musket, a fowling piece & birding piece" valued at £1 5s. and "one sword" valued at 3s. 4d. [EPR 1:188].

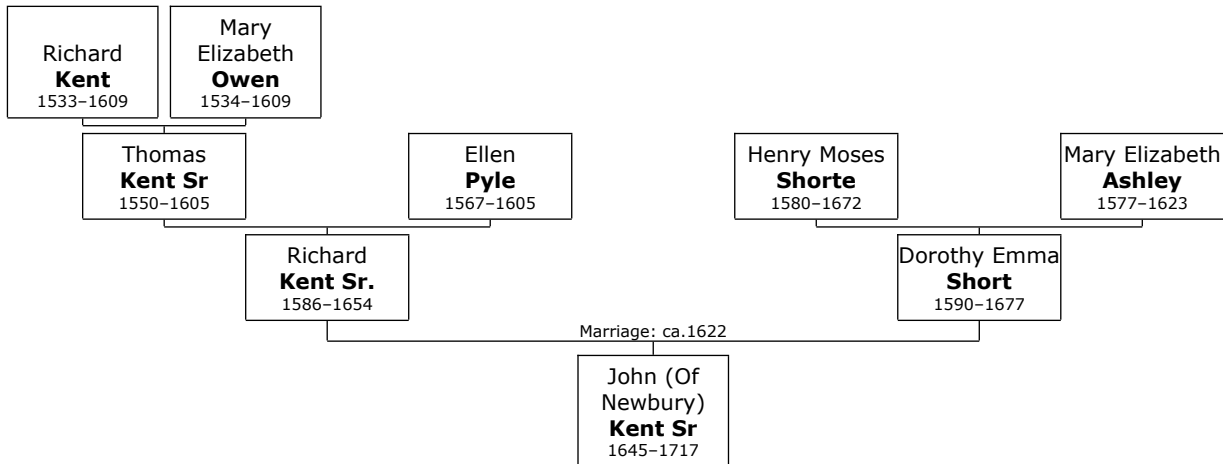
ESTATE: On 2 October 1650, "Richard Kent of Nubery Senior" deposed regarding what Nicholas Easton had told him about land that Easton had sold to Mr. Stephen Dummer [JLR 1:70].

In his will, dated 22 May 1654 and proved 26 September 1654, "Richard Kent Senior of Newberry" bequeathed to "my son Jo[h]n Kent my house and lands ... and if my aforesaid son John Kent die without any heir, then the aforesaid house and lands is to be disposed of [to] Jo[h]n Bishop Junior and his heirs forever"; to "my daughter Sarah or her children the sum of twenty pounds if they come over to be paid when my executor comes to be twenty-one years old"; to "my loving wife Em Kent ten pounds per annum to be annually paid her so long as she liveth, and the fruit of her apple tree yearly, or thirty pounds to be suddenly paid her which she pleaseth"; to "Mary Kent my brother Stephen's daughter which he had by his first wife, one yearling heifer calf"; to "my son Jo[h]n Bishop 100 trees out of my nursery"; to "my son John Bishop my son John Kent in manner as an apprentice till he is complete nineteen years of age ... and at the age of nineteen my son Jo[h]n Kent is to enjoy the land, only to be guided by my overseers till he come to the age of one and twenty"; "my son John Bishop, William Titticum and Richard Bartlett" to be overseers; "the first salmon that is caught in my weir to Mr. Noice & the second to Mr. Roggers of Rowley till my son be of the age of nineteen and then I leave it to my son to do what he sees good" [EPR 1:186-87].

The inventory of the estate of Richard Kent, taken 29 June 1654, totalled £233 3s. 4d., of which £133 was real estate: "one dwelling house," £5; "one barn," £3; "one orchard about the house to the value of 3 acres of land containing 82 bearing trees and a nursery," £40; "23 acres of land in tillage about the house," £46; "24 acres of pasture land," £12;

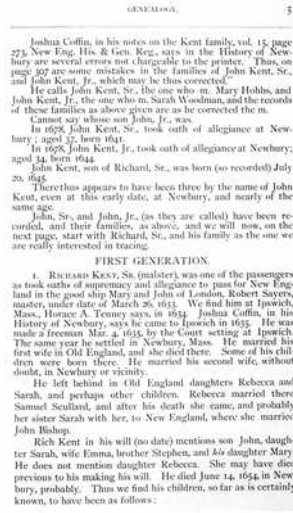
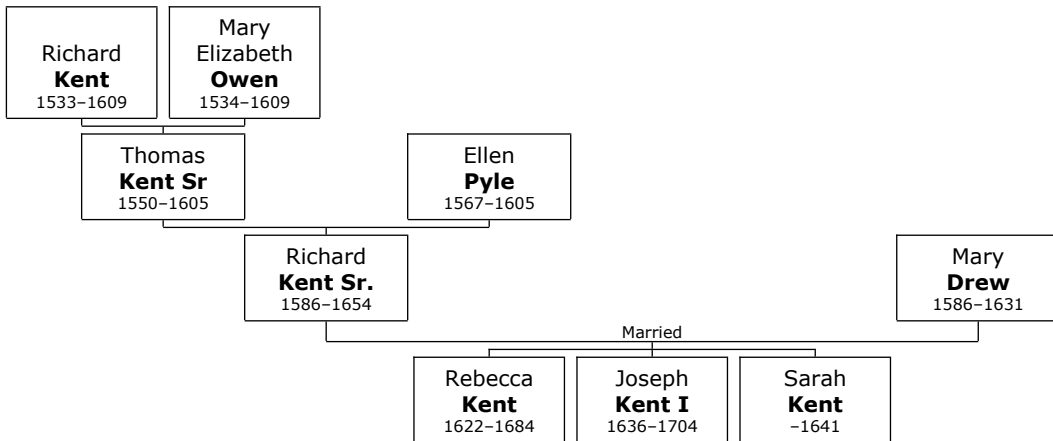


Figure 7: Richard Kent North America, Family Histories, 1500-2000 (December 2020) Book Title: History and genealogy of the Kent family : de[s]cendants of Richard Kent, Sen , who came to America

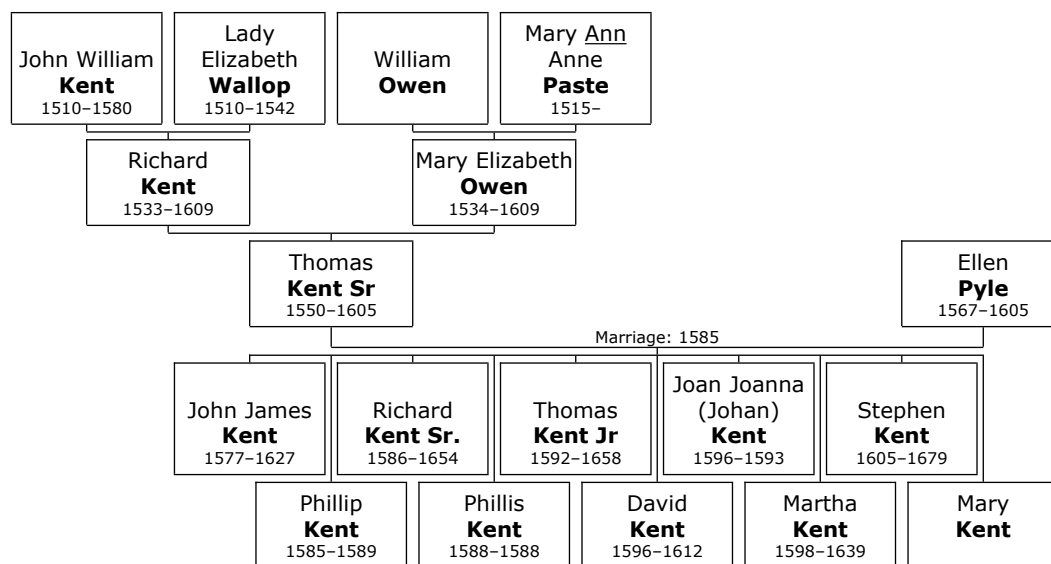

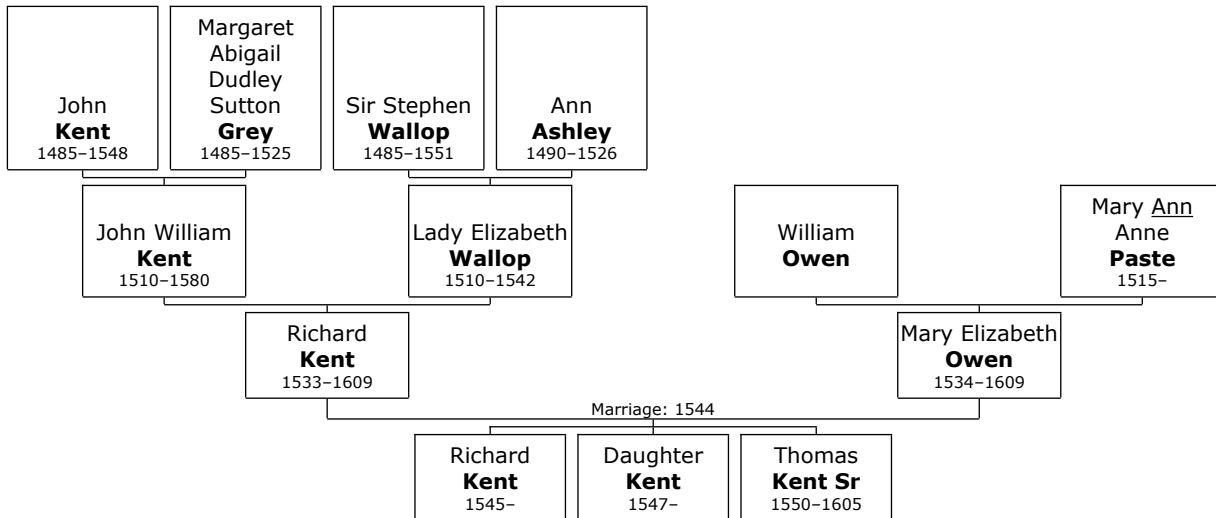

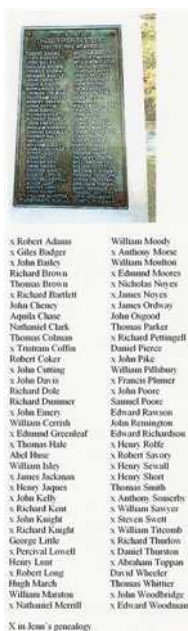


Figure 8: First Settlers Monument Newbury MA - Names (1642)

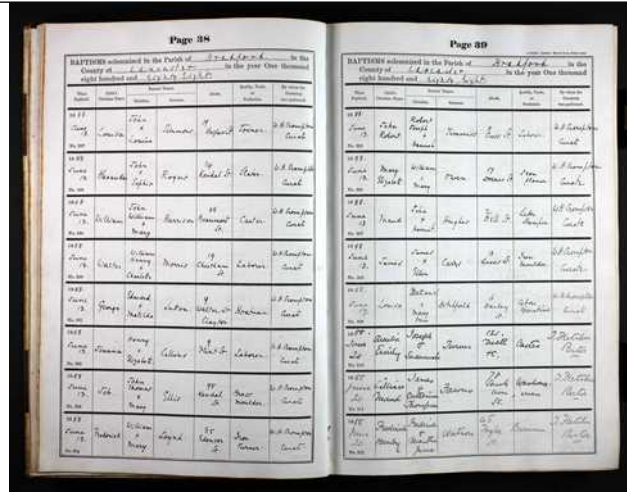
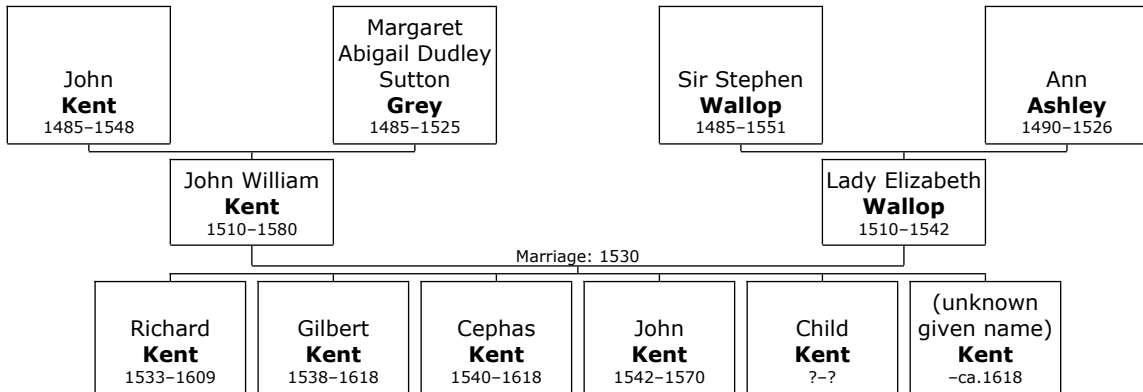


Figure 10: Owen Kent Manchester, England, Church of England Births and Baptisms, 1813-1915

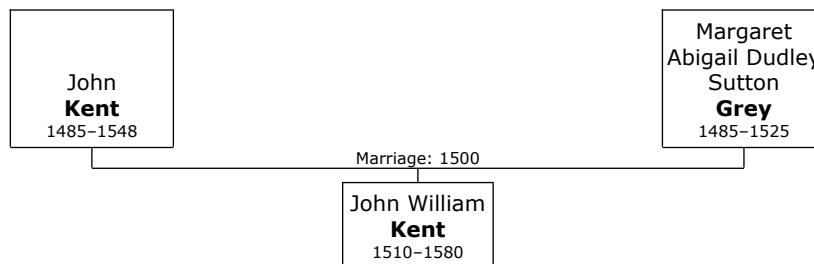

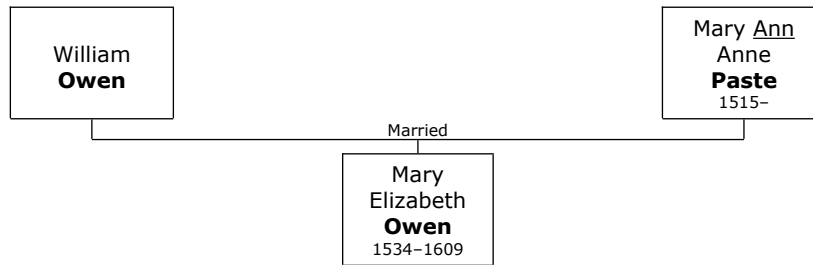

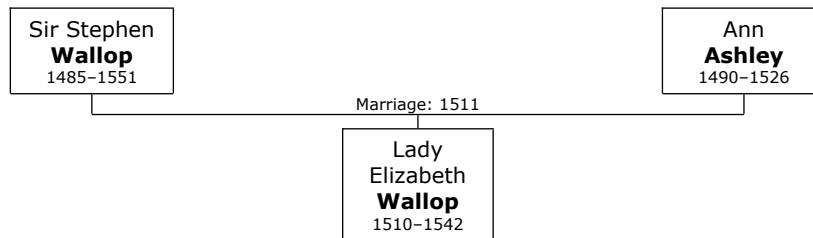

PREFACE

First, it is important that I try to support the data with documents or media that support the data of each individual. This helps to validate and provide confirmation of the genealogy history recorded about a person and their families. In some cases I have seen many forms of data, but I only attached those that provide proof to help support my recordings. If I attached all I could find would provide too much for my computer files and overload the presentation.

In United States history are numerous varieties of record types that have been preserved. Each of these records provide the trail of the people and their documented history. There are many sources that provide information of this documented history. In this book are footnotes of the source documents or places this research has been recorded. There are so many types of sources to mention here, but this book provides some of that information as recorded in my Family Tree Maker (FTM) file.

Some of the data has been found or learned but have no supporting documentation. Why? Because to maintain limited electronic files; and that some of the information has been discovered on many sources. In some cases, it is real information known by people of these families.

Ireland is divided by two territories. Northern Ireland, and The Republic of Ireland (the Irish Free State). Northern Ireland is under the control of British rule. The Republic of Ireland is its own sovereignty nation. The name "Éire" is the nickname or name used for Ireland.

First, one has to understand the land divisions of countries. This helps understanding to find people and where they lived.

One important note about individual and family names. Each surname coupled with given names you will find many of the same name or combination of names. Therefore, other items such as parents, birth, death, marriage, territory, and possible other items are required to ensure one has identified the current person and family.

Enjoy reading, but there is so much to learn. This document will provide a base for anyone wishing to do genealogy research or just adding to this family information.

RESEARCH NOTES

Doing genealogy research is a long term and time-consuming task. If one is doing it for real, they will collect a great amount of data about life of people, the territory they lived, and learn about the uniting of families. For this researcher, there is much learned that is way above what is taught about history in school classes. Research can include working with on-line resources in today's Internet and can include travel to obtain information and documentation from Federal, State, County, City, or towns from records they kept. Cemetery records are a great source found on-line via the Internet.

There are many avenues why folks do genealogy research. For this researcher, I am not writing a book, I am trying to learn of past family and a small bit about them. I am not recording every detail that is possible. If I did, I would not be able to share what I have discovered in this book and I would still be on the road to discovery.

What is in this book is free to all to read, print, or share as they desire. This information is public and can be found by others; therefore, I am not doing this for any monies or profit, just for the pleasure of doing this research and a great retirement hobby for me.

This research has been ongoing between 2000 to 2021 to compile and record in this book. There are many resources, these are just some of them.

3. Using an Internet browser to search by varies names or phrases does help locate some information.
4. Primary source documents such as: US Census, Birth, Death certificates, cemetery records, civil documents, and immigration records or other documents that support the validation of family names and their link to relatives.
5. Find-a-Grave: [<https://www.findagrave.com/>]. In the attached files you may see the term "**Memorial ID**" with a number sequence. By going to the Find a Grave web site and entering this Memorial ID, that will take you to the grave information that has been recorded by folks who go to cemeteries and document the graves. In some cases, you will see the grave maker and other information folks have recorded for that person. In some cases, there are links to parents, siblings, and children along with spouses that all have a Memorial ID recorded.
6. Historical Societies and Internet Genealogy resources

NOTES:

1) ANCESTOR: Also known as a forefather, fore-elder or a forebear.

2) DESCENDANT: Are descending after a forefather, fore-elder or a forebear.

- **Meaning of "direct descendant" as opposed to "indirect descendant"**

1. A direct descendant is someone who can trace their lineage by "child" relationships all the way back to the desired ancestor.

2. A non-direct descendant has to go through a "cousin" or "by marriage" or some other non-child relationship in order to find the desired ancestor.

Definition of genealogy.

1. An account of the descent of a person, family, or group from an ancestor or from older forms.
2. Regular descent of a person, family, or group of organisms from a progenitor or older form: pedigree. The study of family ancestral lines.

Introduction

The following pages list data for all known family members as of January 25, 2022.

Each immediate family is presented in their own section that contains a graphical family tree as well as a description with information about each referenced person and their children.

Any files/Media collected is attached to a person or family is pictured with each family.

The child section provides information about the children of the preceding couple. When a child has offspring of their own this is presented in a separate family section for that child. In this case a '+' is used to denote that an individual will appear later in the book as a parent with his/her own children and there is a link to the appropriate family reference number. Each spouse and their children is a "Nuclear Family".

For children with partners but no offspring the partner data is given with the reference family.

Roman numerals, followed by a period, are used to indicate the birth order.

In the chapter titled "Family of the Starting Person" the ancestors of Thomas Kent are presented in a form of an enhanced Pedigree Chart which displays the graphic representation of their direct-line ancestors and the children of the couple. This chapter contains information about the couple whose ancestors are listed in the later chapters.

The chapter titled "<HeadlineFamilies>" provides details (as known as of this publication date) for the ancestors of Thomas Kent.

There is a chapter for each generation.

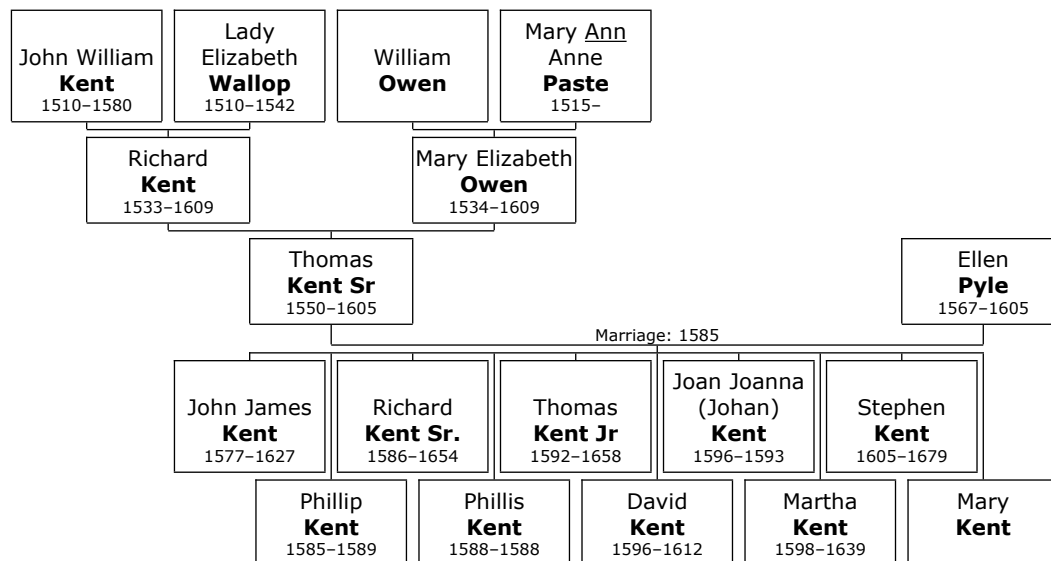
Relatives are listed in the order of the nearness of their relationship.

This document reports the details of 31 individuals, of whom 17 are male and 13 are female. The sex of one individual is unknown. Of the 22 individuals with recorded birth and death dates, the average lifespan was 54.3 years. Of these, 14 males averaged 57 years, and 8 females averaged 49.4 years. The longest living male was Gilbert Kent (1538–1618), who died aged 80. The longest living female was Dorothy Emma Short (1590–1677), who died aged 87.

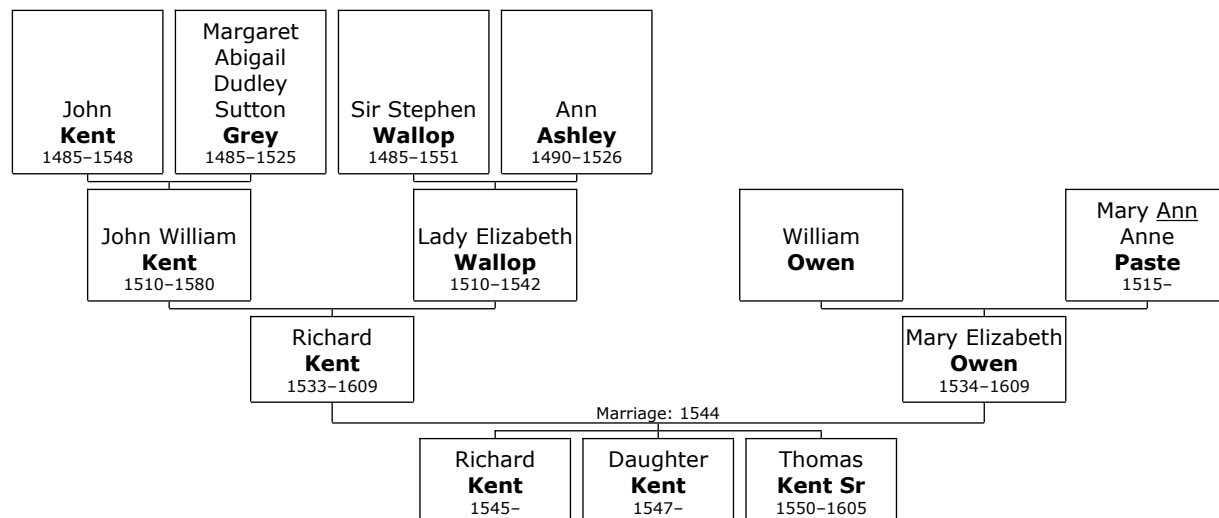

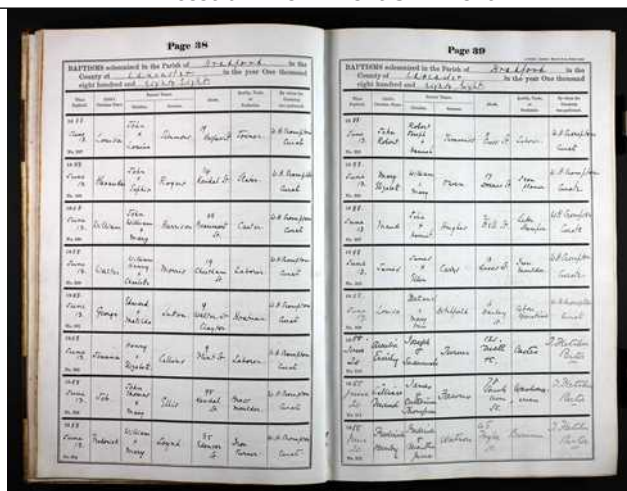
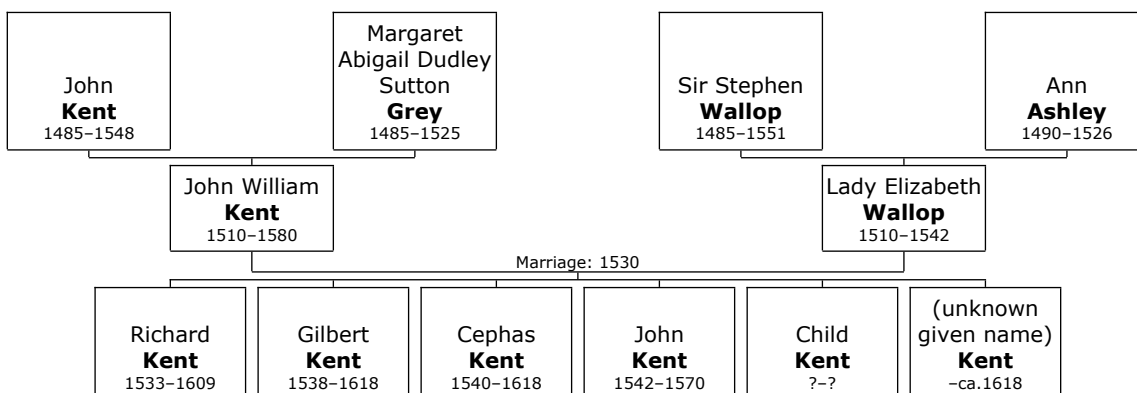


Figure 3: Owen Kent Manchester, England, Church of England Births and Baptisms, 1813-1915 (131 July 1888) Baptism

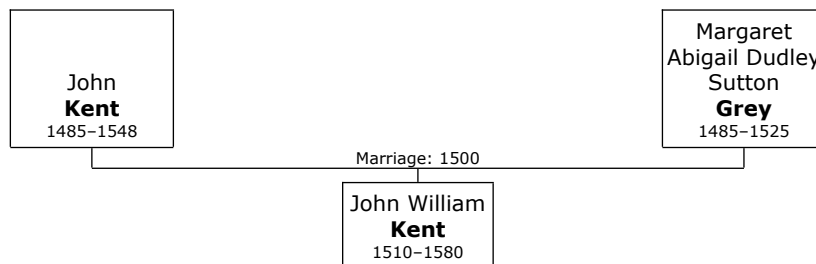

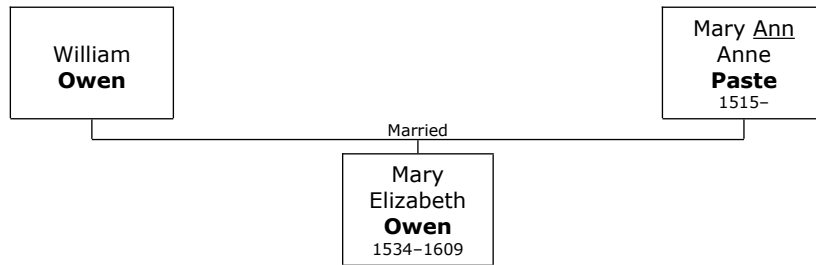

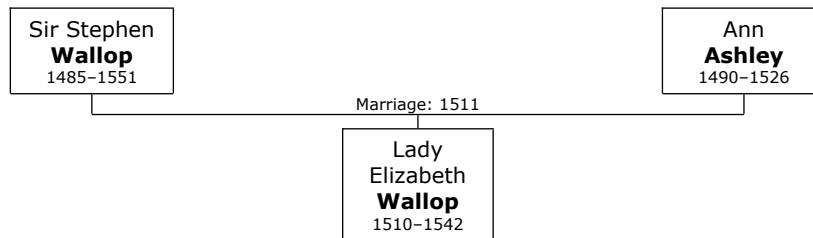
